The Committee considered and discussed appropriating in the 2014 Dodge County Budget, excess revenues in the amount of \$40,000 from Business Unit 1415, In Rem Property, to Business Unit 1448, Monarch Property Site Cleanup, for expenditure in 2014 to pay costs for environmental remediation at the former Monarch Iron Range property located in the City of Beaver Dam. A motion was made by Mattson, and seconded by Nelson to approve and forward to the County Board for consideration at its February 17, 2015 meeting, a Resolution authorizing and directing the Dodge County Finance Director to appropriate in the 2014 Dodge County Budget, excess revenues in the amount of \$40,000 from Business Unit 1415, In Rem Property, to Business Unit 1448, Monarch Property Site Cleanup, to pay costs for environmental remediation at the former Monarch Iron Range property located in the City of Beaver Dam. Motion carried.

The Committee considered and discussed the former MetalFab Property, located at 401 Madison Street and 415 Madison Street, in the City of Beaver Dam, regarding the future use of the building on the site, and an update regarding the liquidation sale by tenant.
