**Consider, Discuss and Take Action:**

***Bid for roof replacement project at the Dodge County Administration Building:*** Bids have been received for this project. The budget for this project was reduced to \$190,000. Pioneer Roofing can complete the project at a cost of \$168,999. **A motion** was made by Dennis Schmidt and seconded by Mark Roesch to hire Pioneer Roofing for the roofing project.

***Bid for the Security Electronics upgrade at the Dodge County Detention Facility:*** Bids have been received for this project. A recommendation from Mead & Hunt was made to award the project to Elmstar Electric Corporation. **A motion** was made by Chester Caine and seconded by Tom Nickel to hire Elmstar Electric Corporation for the Security Electronics upgrade.

***Room Usage Courthouse for Restorative Justice:*** The room has been looked at by Restorative Justice and this area will work for them. **A motion** was made by Tom Nickel and seconded by Dennis Schmidt to allow Restorative Justice to occupy the location in the reserve Judge's Chambers.

***Quote to replace door at the Legal Service Building:*** A quote was received from Hometown Glass & Improvements. The rotating door would be taken out and replaced with regular doors which would be handicap accessible. **A motion** was made by Mark Roesch and seconded by Chester Caine to hire Hometown Glass & Improvement for the door replacement.

***Quote to repair stone at the Dodge County Courthouse:*** A quote was received from Statz Restoration to install a Urethane Deck Coating, install additional support for four stones, and if weather permits replace one stone panel. **A motion** was made by Tom Nickel and seconded by Mark Roesch to hire Statz Restoration for the stone repair.

Russ Freber updated the committee on the projects at the different locations.

*Parking Lot* is complete.

### **Henry Dodge Office Building**

*Elevator Repair* is complete. Elevator is up and running.
