Stat. 48.981(7) (limiting public disclosure of child-specific information disclosed to child death review team); Wis. Stat. 146.82(2)(b) (restricting redisclosure of medical information contained in records obtained pursuant to law); Wis. Stat. 48.78(2)(a) (restricting redisclosure of information in records of child protective agency); and Wis. Stat. 48.396 (limiting disclosure of law enforcement records of children).
