
Here are a couple of other fun facts about her:

# **Clear Gains Smoke-Free Housing Outreach**

The Wisconsin Wins campaign for Dodge, Jefferson, and Waukesha Counties has completed all compliance investigations for 2015. We want to say a big thank you to our local Law Enforcement partners and to the youth who assist us with the compliance investigations. We saw a significant drop in the non-compliance rate from 2013 to 2015 and we will continue to encourage retail establishments to make sure that their employees are receiving the training they need to be in compliance with the law.


