Approval of Minutes:

Medical Examiner's office report:

March of next year we will have a second person in the medical examiner officer as a deputy

Sheriff's Office: Drug take back effort has been successful. Sheriff's office collected 5# of just meds, no containers. Clarification on the flyer to see if those agencies have gotten their drop boxes.

Pastor Bauer: As his job as a sheriff chaplain, he has seen an increase in telling children their parents have passed away, it has become very difficult.

Dodge Public Health: CARES coalition, planning for an April summit, speaker and other details are currently being worked out. We are just beginning to tally our safe sleep survey. We were able to have a presence at the fair and to survey a larger more diverse population.

City of Watertown Public Health: Has a new car seat technician, MCH grant will continue with safe sleep working with child care providers and Childrens health alliance

PJ reminded us that Jeff who works in his office is also a car seat technician and to keep him in mind when car seat checks are needed.

Community Pediatrics:

10th anniversary staff member built a PVC stand up for 4 foot 9 for child to stand under to see if they need to still be in a booster seat. She will loan out to those clinics or agencies that are interested in using it to educate parent's proper car seat law.

AAP conference this weekend and will attend her section on safe sleep. Continues to educate clients on safe sleep.

Psych Associates:

Grief counseling will start in the middle school in January. Trying to get more counselors into the school to help with grief

Working with mental health coalition to get staff in school to identify mental health crisis with the children.

Childrens Health Alliance:

Abby Collier updated the group with the KKA meeting in November. Also bringing in National conference. Midwest Injury alliance on Sunday November 8 and morning on the 9th. And KKA is afternoon of 9th and day of November 10. Strong focus on Opiates. A lot of national speakers. Summit is free to attend, public health is mandatory training/conference for their MCH grant.

Stat. 48.78(2)(a) (restricting redisclosure of information in records of child protective agency); and Wis. Stat. 48.396 (limiting disclosure of law enforcement records of children).
