- 5. **MEDICAID RENEWALS:** A discussion was held regarding responsibility for Medicaid renewals. After discussion, it appeared to be the consensus of the commission that there should be a written document explaining the commitment to working together on renewals. Attorney Phillips was instructed to prepare a Memorandum of Understanding for consideration and approval at the August 29, 2016 Annual Meeting.
- 6. ASSESSMENT RATE SETTING FOR 2017: Wiley provided the 2017 rate assessment calculation based on the filed 2015 Nursing Home Medicaid cost report. The Commission discussed the 2016 assessment rate relative to the 2014 Nursing Home Medicaid Cost Report reported net surplus. Based on the goal to smooth out the assessment rates year over year, the prevailing consensus was that the 2016 assessment rate would accomplish that goal. No additional action was brought forward regarding the

2014 net surplus. Wiley explained that \$218,256 assessment pertains to all other MCHA counties other than Dodge. He explained that it was based on a five-year rolling average of their utilization rate. Motion by Washington County to set the 2017 assessment rate at \$218,256; seconded by Ozaukee. Motion carried.

- 7. **LEADING CHOICE NETWORK:** The Commission was updated regarding conference calls between the Reinhart law firm, Attorney Andy Phillips, Woodland Enhanced Health Services (Clark County), Mississippi Valley Health Services Commission (LaCrosse County), and Clearview/Marsh Country Health Alliance. All three commissions will not be joining LeadingChoice Network at this time but have the option to do so in the future if they so choose.
