**Open Session:**


Reconvened into Open Session at 7:05 p.m.

**COMMISSION MEMBERS PRESENT: Hillard, Herren, Birschbach, and Kuhn**


**OTHERS PRESENT: Sergeant Tim Behselich – Jefferson County Sheriff's Office**
