#### 5. FINANCIAL PRESENTATION ~ BILL WILEY:

- Memorandum of Understanding ("MOU"): Wiley reported that the current list of MCHA county residents would be sent out on November 29 to the appropriate county Human Services Directors. This notification would be sent via certified mail. The Commission members requested an update at the February meeting on the responses and levels of cooperation of the MOU.
- Current Financial Update: Wiley reviewed the current status of the 2016 MCHA budget. 2016 revenues are close to budget with the only concern that the nursing home census has dipped slightly below budget since October. It is beginning to rebound but has not yet reached our budgeted census yet.

The direct expenses were higher than budget due to pushing more expenses to the household instead of retaining at the facility level. Overhead expenses are lower due to this shift as well.

Wiley also reviewed the proposed Medicaid rates with the members. He said the proposed rates look very good but in fact thought they were suspect. He will report on the accepted rates at the February meeting.
