Stephanie Levenhagen introduced Diane Coulter, Aging & Disability Resource Specialist, to the members of the committee. Diane presented marketing strategies being utilized. Included was the new banner, updated brochures, pens, notepads, bags, and hot/cold packs.

- 2. To move forward with combining boards, each committee would need to approve dissolving their separate committees. Once approved, the recommendation would then go to the Human Services and Health Board to approve and dissolve both committees before a new committee was created. Discussion followed.
- 3. **Review of the Dodge County Human Services and Health Board minutes:**Stephanie Levenhagen briefly reviewed the February 1st and March 8th minutes provided to ADRC Governing Board members at the meeting.
