3. **APPROVAL OF MINUTES FROM THE NOVEMBER 28, 2016 SPECIAL MEETING OF THE MEMBERS AND COMMISSION BOARD AND FEBRUARY 27, 2017 QUARTERLY FINANCIAL MEETING OF THE COMMISSION BOARD OF MARSH COUNTRY HEALTH ALLIANCE:**

Motion by Waukesha County; seconded by Columbia County, to approve the November 28, 2016 Minutes and the February 27, 2017 Minutes, as amended. Motion carried.

5. **DISCUSSION OF POTENTIAL AMENDED AND RESTATED INTERGOVERNMENTAL COOPERATION AGREEMENT ("IGA"):**

A discussion was held regarding the Amended and Restated Intergovernmental Cooperation Agreement ("IGA") Attorney Phillips drafted; the document incorporates information from the three former Amendments to the IGA. No action was taken today; Attorney Phillips will make the requested changes and a new draft will be sent out to the Supervisors and Human Services Directors for further review. The Amended and Restated IGA will be on the Agenda for the Annual Meeting Agenda, set for **Monday, August 28, 2017, at 10 a.m.**

6. **CHANGES TO CLEARVIEW BEHAVIORAL HEALTH: Changes to Clearview Behavioral Health:** Hooper summarized conversations she has had with the Department of Quality Assurance and monitoring admissions and waiting lists for the Committee. The consensus of the Dodge County Health Facilities Committee was to move forward

with reducing the nursing home license from 140 to 130 beds and creating Clearview Behavioral Health III with ten (10) beds in the near future, then possibly reducing the nursing home license from 130 to 120 beds and creating Clearview Behavioral Health IV with ten (10) beds by the end of 2018. Lori Kurutz, Clearview Director of Support Services, also gave a PowerPoint presentation comparing the admission and discharge statistics from 2015 to the present.

7. **ASSESSMENT RATE SETTING FOR 2018:** Wiley reviewed the four pages of financial documents with the members. He stated that according to the 2016 Marsh Country Health Alliance Cost Report, MCHA showed a loss of \$3,319,923. Once the other areas of Clearview were removed from the calculation, MCHA showed a loss of \$1,303,433 from which the assessment would be determined. Wiley then provided the counties an estimate of their 2018 assessment which would be \$336,825.00 of all counties other than Dodge.

Wiley then reviewed with the members the allocation of overhead for all areas of Clearview. Additional reports were provided showing the billed days by payer and occupancy rates of the two facilities of MCHA. The final report provided showed the utilization rate for all counties, along with their estimated 2018 assessment.

Several members had questions concerning the allocation of overhead expenses. Members asked Wiley for an explanation of the Cost Report calculations and the Program Income Statement.

It was requested that the utilization report have a column added that shows the change in utilization by county from the previous year to the current year on which the assessment rate is based.

8. **2017 BUDGET STATUS UPDATE:** Wiley provided the members an update of the 2017 budget through April 30, 2017. He stated that revenues were down slightly but not as much as what census would expect. He stated that several contributing factors are assisting in helping the overall Clearview 2017 budget. He stated that the Brain Injury Center received an unexpected increase in its Medicaid rate. Also, Clearview had received half (½) of the settlement for the defective siding issue. The other portion will be received at some unknown point in the future. He also stated that Medicare revenue is higher than last year which corresponds to the census trends that were presented.
