Engage with Law Firms to Prosecute Claims against Certain Opioid Manufacturers

TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN **MEMBERS**:

WHEREAS, Dodge County ("County") is concerned with the recent and rapid rise in difficulties facing County citizens, residents, and visitors in relation to problems arising out of the use, abuse and overuse of opioid medications, which according to certain studies, impacts millions of people across the country; and,

WHEREAS, issues and concerns surrounding opioid use, abuse, and overuse by citizens, residents and visitors are not unique to the County and are, in fact, issues and concerns shared by all other counties in Wisconsin and counties across the country, as has been well documented through various reports and publications, and is commonly referred to as the Opioid Epidemic ("Opioid Epidemic"); and,

WHEREAS, the societal costs associated with the Opioid Epidemic are staggering and, according to the Centers for Disease Control and Prevention, amounting to billions of dollars annually; and,

WHEREAS, the National Institute for Health has identified the manufacturers of certain opioid medications as being directly responsible for the rapid rise of the Opioid Epidemic by virtue of their aggressive and, according to some, unlawful and unethical marketing practices; and,

WHEREAS, certain opioid manufacturers have faced civil and criminal liability for their actions that relate directly to the rise of the Opioid Epidemic; and,

WHEREAS, the County has spent significant unexpected and unbudgeted time and financial resources in its programs and services related to the Opioid Epidemic; and,

WHEREAS, the County is responsible for a multitude of programs and services, all of which require the County to expend resources generated through state and federal aid, local property tax levy, fees and other permissible revenue sources; and,

WHEREAS, the County's provision of programs and services becomes more and more difficult every year because the costs associated with providing the Opioid Epidemic programs and services continue to rise, yet the County's ability to generate revenue is limited by strict statutory levy limit caps and stagnant or declining state and federal aid to the County; and,

WHEREAS, financial and other resources the County expends in addressing, combatting and otherwise dealing with the Opioid Epidemic are resources that cannot be used for other critical programs and services that the County provides to County citizens, residents and visitors; and,

WHEREAS, the County has been informed that numerous counties and states across the country have filed or intend to file lawsuits against certain opioid manufacturers in an effort to force the persons and entities responsible for the Opioid Epidemic to assume financial responsibility for the costs associated with addressing, combatting and otherwise dealing with the Opioid Epidemic; and,

Briesen & Roper, s.c., Crueger Dickinson LLC, and Simmons Hanly Conroy LLC (the "Law Firms") related to the potential for the County to pursue certain legal claims against certain opioid manufacturers; and,

WHEREAS, the Law Firms have proposed that the County engage the Law Firms to prosecute the aforementioned claims on a contingent fee basis whereby the Law Firms would not be compensated unless the County receives a financial benefit as a result of the proposed claims, and the Law Firms would advance any and all claim-related costs and expenses associated with the claims; and,

WHEREAS, the Law Firms have assured the County that any and all of the costs and expenses associated with the claims against certain opioid manufacturers would be borne by the Law Firms; and,

WHEREAS, the Law Firms have provided a proposed engagement letter, ("Engagement Letter") specifying the terms and conditions under which the Law Firms would provide legal services to the County and otherwise consistent with the terms of this Resolution; and,

WHEREAS, the County has been informed that the Wisconsin Counties Association has engaged in extensive discussions with the Law Firms and has expressed a desire to assist the Law Firms, the County and other counties in the prosecution of claims against certain opioid manufacturers; and,

WHEREAS, the County would participate in the prosecution of the claim(s) contemplated in this Resolution by providing information and materials to the Law Firms and, as appropriate and allowed by law, the Wisconsin Counties Association as needed; and,

WHEREAS, the County believes it to be in the best interest of the County, its citizens, residents, visitors and taxpayers to join with other counties in and outside Wisconsin in pursuit of claims against certain opioid manufacturers; and,

WHEREAS, by pursuing the claims against certain opioid manufacturers, the County is attempting to hold those persons and entities that had a significant role in the creation of the Opioid Epidemic responsible for the financial costs assumed by the County;

SO, NOW, THEREFORE, BE IT RESOLVED, that the Dodge County Board of Supervisors authorizes the appropriate county officials to execute an Engagement Letter, provided that such Engagement Letter contains terms and conditions satisfactory to the County, including, but not limited to, a provision that specifies that all costs, expenses, and attorneys' fees shall be borne by the Law Firms and reimbursed only if the County receives a financial benefit from the prosecution of the proposed claim; and,

BE IT FURTHER RESOLVED, that the County shall endeavor to faithfully perform all actions required of the County in relation to the claims contemplated herein, and hereby directs all the County personnel to reasonably cooperate with and assist the Law Firms in relation thereto; and,

BE IT FINALLY RESOLVED, that the Dodge County Clerk shall forward a copy of this Resolution, together with the signed Engagement Letter, to the Wisconsin Counties Association, 22 E. Mifflin Street, Suite 900, Madison, Wisconsin, 53703.



Finding F-CC-8703: The State agency does not have policy in place to ensure that local agencies share appropriate information with WIC local agencies in the state and with other local agencies in other State agencies.

The SA does have a confidentiality policy for the LA to follow. Both clinics we visited, Dodge County Human Services and Health Department and Fond du Lac County Health Department, had confidentiality issues in the area where certification took place. Individuals had certification conversations in areas where someone else could overhear. In Fond du Lac County Health Department, individuals were interviewed at a counter. Sometimes there were two participants at the counter at the same time. This issue was a finding in the most recent SA review. Although the LA responded to the required corrective action plan and the state approved their plan, the corrective action had not been implemented. In Dodge County Human Services and Health Department, participants are interviewed at a desk, however; the counter was only a few feet away and individuals at the counter and sitting near the counter could overhear the conversations. FNS discussed these situations during our visit at the local agencies.

Required Corrective Action: The State agency policy must adequately address local agency sharing of information with other WIC State agencies as required.

Although the state policy addresses sharing with other WIC State and local agencies, it does not address confidentiality as it is described in this finding. The SA must amend their confidentiality policy to address confidentiality practices in close settings. In addition, the SA must assess a finding with both clinics and require acceptable corrective action to bring the issue into compliance. Submit the approved correction plans from Fond du Lac Health Department and Dodge County Health and Human Services Department.

Finding Status: Cited

(The State Agency must submit a CAP to address the finding.)

Finding F-CR-409: The required nondiscrimination statement and Civil Rights complaint procedure is not included on all outreach materials and application/certification materials.

The nondiscrimination statement was missing from the Dodge County Human Services and Health Department's half-page WIC application mailer provided to community partners.

Required Corrective Action: The State agency must include the nondiscrimination statement and Civil Rights complaint procedure on all outreach materials (other than nutrition education materials) such as leaflets, brochures, bulletins, news media PSAs, WebPages, etc., as well as, on all application/certification materials. Please provide a plan of action and a timeline for completion.

Please ensure the Dodge County Human Services and Health Department includes the nondiscrimination statement on all outreach and/or application materials provided to the general public and community partners. Submit a copy of the revised application mailer or other documentation showing how this has been addressed.

Finding Status: Cited

(The State Agency must submit a CAP to address the finding.)

P67 FNS 2017 ME Results

Finding ADHOC-F-1763: Dodge county uses a combined hemoglobin and lead test consent form. Applicants are not fully informed that the lead test is optional and not a condition of eligibility.

Required Corrective Action: Provide technical assistance to local agencies that provide hemoglobin and lead tests on applicants. Instruct those agencies to inform the applicants the lead test is optional and not a condition of eligibility. Submit copies of technical assistance correspondence to FNS. Include in your submission how you plan to monitor this issue in the future.

Finding Status: Cited

(The State Agency must submit a CAP to address the finding.)

Observation ADHOC-O-2180: At the Dodge County Human Services and Health Department, applicants who were missing documentation and were given a shortened 30-day certification were not advised they could provide the missing documents via mail, email, fax, or in person. At the Fond du Lac County Health Department, an applicant's mother came in with missing documentation along with the applicant's EBT card and appeared to be pressured because she was not listed on the WIC record. The mother was trying to submit the documentation to complete her adult daughter's certification and was not asking for anything else.

Suggestion: FNS recommends providing TA to the LAs regarding different methods missing documentation may be submitted in order to complete the certification process. Please submit a copy of this correspondence to FNS.

Observation ADHOC-O-2156: Caseload continues to decrease for most LAs, including Dodge County Human Services and Health Department. Since WIC Program funding is directly tied to caseload, the LA has seen gradual funding decreases throughout the last several years. Operational costs have remained consistent, while funding has decreased, which has created a potential funding shortfall situation.

Suggestion: In order to keep WIC costs contained within funding amounts, FNS recommends that Dodge County Human Services and Health Department reduce the number of cell phones used by WIC staff, and scrutinize staffing levels and adjust staffing appropriately to its lower caseload. The vast majority of WIC funding is absorbed by staffing costs; with the significant decreases the agency is experiencing, it is essential that staffing be adjusted.

Observation ADHOC-O-2154: The Dodge County Human Services and Health Department clinic had a noticeable lack of breastfeeding promotional posters in the clinic waiting room. Also, breastfeeding referral resources were not available in the clinic waiting room.

Suggestion: FNS recommends adding posters or other material in the clinic waiting room that shows positive images of breastfeeding. Breastfeeding referral resources are available in the WIC Director's office but should also be made openly available for participants in the clinic waiting room.

Management Evaluation Definitions

Clinic: A facility where applicants are certified.

Corrective Action: Actions proposed or taken by an operating organization (State agency or local agency) to change or improve operational effectiveness.

Finding: Identification of non-compliance with program regulations, policies and procedures (associated with a required corrective action).

Food Instrument: A voucher, check, electronic benefits transfer (EBT) card, coupon or other document which is used by a participant to obtain supplemental foods.

Functional Areas: Program activities performed by the State agency which are examined and measured in an ME.

Local Agency: A public or private, nonprofit health or human service agency which provides health services, either directly or through contract, in accordance with WIC Program Regulations Section 246.5.

Management Evaluation: Formal assessment of State agency and /or local agency program operations through on-site and desk review activities.

Noteworthy Initiatives: Projects and practices worthy of recognition and sharing with other State agencies for replication.

Observation: Identification of a weakness involving management practices or unregulated activity (associated with a suggestion).

On-Site: FNS activity performed at a State agency's central office, local agency, or program operating site/location; i.e., activity not performed in FNS offices.

Recommendation: Statement of actions that address observations made in the management evaluation. These actions may or may not be required (associated with an observation).

Required Corrective Action: Statement of actions that must be taken to correct non-compliance with regulations, and with established policies and procedures. These actions may be prescribed or the State agency may be required to determine the actions to be taken (associated with a finding).

State agency: An agency contracted to provide Federal food program administration within its jurisdiction.

Technical Assistance: Guidance and support to State agencies to achieve regulatory compliance and program improvement.
