### Approval of Minutes

### Check on the All Call System (had been carried over)

Smith advised that IT had been testing the All Call System and it should be working properly for all floors.

### Lockdown in the Courtrooms (had been carried over)

Judge Sciascia reported that training he has attended regarding locking down courtrooms involved the judge leaving the room and court security would be in charge of any public. In Dodge County there is not always a security officer or bailiff in courtrooms, the officers and bailiffs cover multiple courtrooms. After meeting with judges and others it was decided that we cannot keep people in the courtrooms if they wish to leave, that we should not use the holding cells for the public, we should lock the courtooms and escort the public out the back doors, and that no one formula can work for every situation. The training in January will address security scenarios per Ketchem and it will be an opportunity for the staff to be involved in situations. The Policy Committee will meet after the January training and put policies together for courtroom lockdowns. Ketchem also advises that department heads should make sure that staff know where to exit the building.

Judge Sciascia wants to further discuss who is responsible for the public if there is no judge or security officer in the courtroom at the next meeting.

# Report on adding room number identification to the inside of rooms

Freber advises that adding room numbers to the inside of rooms is almost completed.

## **Training Committee Report**

Brandsma advises that the Martin Luther King Jr training day is approaching. The first table top has been held with another meeting scheduled for November. Ketchem is updating the Emergency Evacuation Plan.

Mueller is coordinating the upcoming hearings to be held at the BD Municipal Court building – none have been scheduled yet but will be soon.
