**Reports from Visiting Legislative Officials-** None

**Update of County Issues - Marcie Rainbolt, WCA**

- The Wisconsin State budget not moved forward since the last WCA report, however there is a hearing scheduled for Thursday
- WCA is working to clarify grievance procedures for county staff
- The WCA, WI League of Municipalities and the WI Towns Association oppose the proposed Homeowner Bill of Rights in its current form because it preempts local control
- WCA is working to clarify the five day grace period following January 31<sup>st</sup> for delinquent property taxes
- Clarification of Administrative Rule DHS 38 related to drug testing for Food Share participants.

**Discussion and Possible Action on Restructuring of ICC**

Motion by Columbia County and seconded by Dodge County to restructure the 2017-2018 ICC meetings. The meetings will be held six times per year (October, November, March, May, June and August). Motion Approved.

It was also noted that there should be greater emphasis on getting local elected officials to attend the meetings.
