7	WHEREAS, Dodge County recognizes that access to high speed internet service is
8 9	important to Dodge County residents, visitors and businesses, and further recognizes that not all areas in Dodge County have such access; and,

11	WHEREAS, the Dodge County Executive Committee has discussed, supports and
12	recommends the creation of a workgroup to focus on the following goals and objectives: 1)
13	investigate and understand existing and potential broadband access opportunities for Dodge

15	projects that provide or expand broadband access; 4) explore collaboration and regional
16	opportunities to facilitate access throughout Dodge County and the region; 5) consider county
17	investment to secure and further enhance broadband access; and,

19	WHEREAS, the workgroup (hereafter "Broadband Workgroup") will consist of eleven
20	(11) members appointed by the County Board Chairman;

22	SO, NOW, THEREFORE, BE IT RESOLVED, by the Dodge County Board of
23	Supervisors that the Dodge County Broadband Workgroup is hereby created to achieve the
24	goals and objectives established herein; and,

26	BE IT FURTHER RESOLVED, that the Dodge County Board Chairman shall appoint
27	no more than eleven (11) members to the Broadband Workgroup consisting of Dodge County
28	Board Supervisors, representatives from local units of government and Dodge County residents
29 30	having an interest in or expertise in broadband or information technology; and,
31	BE IT FURTHER RESOLVED, that the Broadband Workgroup shall be advisory to
32	the Dodge County Executive Committee and shall develop reports and recommendations in
33	furtherance of the goals and objectives established herein for consideration by the Executive
34	Committee; and,
35	Committee, and,
36	BE IT FURTHER RESOLVED, that members appointed by the Dodge County Board
37	Chairman to the Broadband Workgroup shall be eligible for a per diem and mileage for such
38	service; and,

40	BE IT FINALLY RESOLVED, that the Broadband Workgroup shall disband at the
41	conclusion of the 2018-2020 County Board term on April 21, 2020.
