

WCA's Marcie Rainbolt reported on the status of the state budget. Highlights include:

- Tuition freeze for UW
- 120 million for UW system
- 1.6 billion for k-12 education
- Hold the line on property taxes

She also shared issue areas and some include the following:

- Agriculture, Environment and Land use (clean drinking water)
- Transportation and Public works
- County org and personnel
- Suicide and public safety
- Tax and finance (dark store loophole)
- Health and Human Services

## Cover Crop Incentives

The Farmers for Healthy Soil-Healthy Water offers a Cover Crop Incentive Program for assistance in planting cover crops on farmland within Dodge County.

In 2018 alone, there are 29 producers in the Incentive Program with over 700 acres of established cover crops.

The lake associations within the Dodge County Alliance Group have given away over \$14,000 of free cover crop seed to producers within their respective water sheds.

## On-Farm Research Trials

UW-Extension has conducted over 10 on-farm research trials looking at cover crop species and various planting methods.

These trials will continue to be performed by UW-Extension to further understand the benefits of conservation practices in Dodge County.
