Richard and Gwen Wangerin – Request for a variance to the terms of the water setback provisions of the Dodge County Shoreland Protection Ordinance to allow an above ground swimming pool to be located approximately 52 feet within the required water setback lines. The site is located in part of the NW ¼ of the SW ¼, Section 11, Town of Westford, the site address being W10406 Sunny Point Road.
