• **Kelly Rae Menden** –Lot 26, BLK 1 Sinissippi Bay Subdivision, located in part of the NE ¼ of the NE ¼, Section 32, Town of Hubbard, the site address being N5256 Wildcat Road:

Following the On-site visits, the Board reconvened the meeting of the Dodge County Board of Adjustment at 8:00 P.M. in Rooms 1H and 1I located on the first floor of the Administration Building, located at 127 East Oak Street, Juneau, Wisconsin to hold the public hearings.

PUBLIC HEARING

Kelly Rae Menden – Request for a variance to the terms of the water setback provisions of the Shoreland Protection Ordinance to allow the construction of a fence on this lot where said fence will be located approximately 15 feet from the ordinary highwater mark of Lake Sinissippi, or 60 feet within the required water setback lines and therefore is prohibited by the Code. The site is known as Lot 26, BLK 1 Sinissippi Bay Subdivision, located in part of the NE ¼ of the NE ¼, Section 32, Town of Hubbard, the site address being N5256 Wildcat Road.

Motion by Jon Schoenike to allow the construction of a fence on this lot where said fence will be located approximately 15 feet from the ordinary highwater mark of Lake Sinissippi subject to the following conditions:

- 1. The fence shall meet the requirements of an "open fence" as defined in the Ordinance
 - Fence, Open: A fence, including any gates in said fence, that does not have privacy slats, pickets or other solid coverings blocking view and in which openings between the materials of which the fence is constructed represent not less than fifty (50) percent of the total surface of the fence when viewed perpendicular to the face of the fence.
- 2. The fence shall not exceed a height of 3 feet.
- 3. The fence shall not be located closer than 15 feet to the ordinary high water mark of the lake.
- 4. The fence shall be removed within 10 years of the issuance of the permit for the fence.
