- 1. Meeting was called to order by Chair Larry Bischoff at 8:15 a.m.
- 2. Members present: William Foley, William Muche, Lisa Derr, Larry Bischoff, Dale Macheel, Allen Behl and James Qualmann.
 - Others present: Other staff and non-committee members included John Bohonek, County Conservationist, Kathy Turner, NRCS, Sarah Marks, LWCD/HSHW Intern, Adam Zimmerman, Ruth Johnson and Becky Justmann, LWCD.
- 3. Public comment: Ruth Johnson commented that she attends the meeting to keep up with what's going on in Dodge County. Ruth complimented the Committee and shared that she admires and respects the Dodge County Committees and that Dodge County is doing a good job.
 - John informed the LWCC that Wednesday August 28, 2019 will be Sarah Marks, HSHW/LWCD intern's last day.
- 4. Motion by Lisa Derr and seconded by William Muche to approve the minutes from the July 22, 2019 meeting.

- 7. Manure Storage Ordinance Updates
 - Adam Zimmerman made a request to the committee to have the penalty waived
 that he received for not getting a Manure Storage Permit for the construction of a
 new manure pit. Adam explained to the committee the events leading up to the
 construction of his current manure storage pit. Motion by Lisa Derr and seconded by

- Clyman violation: John has received an email from the owner's daughter that he
 read to the committee. They want to convert the current manure storage unit to
 feed storage. John asked the committee for their direction on the matter. A timeline
 was set by the committee for the owner's to have a plan submitted. Fees for the
 violation will start following the next LWCC meeting.
