A. Update: State Budget

Ms. Bell reported to the Board she and Monica Hooper participated in a phone call about Maintenance of Effort for Crisis Intervention Services to receive additional recoupment. We will qualify as a region because we contract with Northwest Connections for crisis coverage during non-business hours. Ms. Bell will update the Board as more information comes in.

B. Foster Care recruitment efforts

Becky Bell informed the Board that Human Services and Health Department signed a contract with the Beaver Dam movie theatre to run a video clip before movies about the Foster Care recruitment efforts.

C. Urban Rural Women's Substance Use Services grant

Ms. Bell informed the Board that Human Services and Health Department applied for this grant in the amount of \$300,000. The grant proposal includes as dually credentialed individual to assist with the investigation process to identify women in need of treatment services more quickly. The grant would also fund 2 recovery support specialists along with funding for detox and residential treatment. Ms. Bell should hear something in regards to the grant sometime in November and will update the Board when the decision is made.
