Dodge County Crime Prevention Funding Board Annual Report

Crime Prevention Funding Board Purpose and Makeup

The purpose of the Dodge County Crime Prevention Funding Board is to provide funds to qualifying entities for the purpose of funding crime prevention programs.

The board according to Wisconsin State Statute shall consist of:

- (1) The presiding judge of the circuit court, or his or her designee,
- (2) The district attorney, or his or her designee,
- (3) The sheriff, or his or her designee,
- (4) One of the following county officials, or his or her designee: ...(b.) ...the county administrator...
- (5) The chief elected official of the largest municipality in the county, as determined by population, or his or her designee,
- 6) A person chosen by a majority vote of the sheriff and all of the chiefs of police departments that are located wholly or partly within Dodge County, and
- (7) A person chosen by Dodge County's public defender's office.

Makeup of Annual Report

The Dodge County Crime Prevention Funding Board submits a report regarding its activities to the Dodge County Clerk of Court, Dodge County Board, and the legislative bodies of each municipality that is located wholly or partly within Dodge County. The report shall include the following information:

- 1. The name and address of each entity that received a grant, including contact information for the leadership of the entity.
- 2. A full accounting of all funds disbursed by the treasurer at the direction of the crime board, including the amount of the funds disbursed, the dates of disbursal, and the purposes for which the grant was made.

Report

In 2018, two grants were awarded in the amount of \$3000 each. Those grants were issued to:

5-Stones Beaver Dam Tracy Sheffler N4834 Catbird Road Beaver Dam, WI 53916 920-344-0971

And

C.A.R.E. for Dodge County Wendy Borner PO Box 84 Beaver Dam, WI 53916 920-631-7155

Funding was disseminated at the direction of the committee on Thursday, October 25, 2018 to both organizations. Both organizations received a grant of \$3,000 totaling \$6,000 from the Crime Prevention Fund.

Purposes for which the grants were awarded:

The Crime Prevention Funding Board elected to award two grants due to the need described in the applications received as well as the obvious need in the community that all members of the board are well aware of.

The purpose of the grant issued to 5-Stones of Beaver Dam was to provide various forms of awareness, education, prevention, networking and collaboration to fight the giant of sex trafficking in our area.

The purpose of the grant issued to C.A.R.E. for Dodge County was to provide assistance in funding treatment programs and training addiction recovery coaches. This funding is meant to assist those who are currently using drugs or are currently in recovery in being successful in completing the road to recovery.
