Minutes

1. **Call to order:** District Attorney Kurt Klomberg called the meeting to order at 3:04 p.m.

3. **Public Comment:** None.
4. **Approval of Minutes of April 16, 2019:** Motion by Judge Sciascia, 2nd by Jim Mielke to approve the July 9, 2019 minutes as presented. Motion carried.
5. **Report of TAD IDC Program Director:** Discussion held regarding budget, capacity of program, grant funding and current active and termination numbers. Discussion regarding number of defendant in jail indicating a need for treatment.
6. **Informational Discussion regarding sober living developments:** Becky Vis and Bev Grudex spoke regarding a sober living home that will be opened. 4 males in one house for up to 6 mths. Becky Bell spoke regarding grant funds that have been received, and that they will do an evaluation to make sure that the funds will be allocated properly. Becky Bell will provide more information regarding the grant funding at the next meeting.
7. **Discussion and Possible action on modification of the 60 day rule for admission into DTC and IDC:** Ramneek Button suggested change to rule that 60 day clock starts at the point of the offer. DA Klomberg speaks to changes in the District Attorney's Office to make offer on the onset of the file to insure no delay. Motion to eliminate 60 day rule by Judge Sciascia, 2nd by Ramneek Button. The vote was 2 to eliminate the rule and 4 to keep the rule, motion fails.

Program Changes/Notes:

1. No staff changes to report for this quarter.
2. Graduations: IDC: 7 participants graduated. The total for 2019 is 13.
DTC: 0 participants graduated. The total for 2019 is 7.
3. Three Thinking for a Change classes concluded this quarter with 15 participants completing. Two groups are starting in October.
4. TAD grant application for 2020 was submitted.
5. We were notified by the Office of Justice Programs that Dodge County was awarded the three year grant to expand the Drug Treatment Court program. The expansion will increase the capacity for Drug Court to serve more individuals, sober living and transportation services.
6. Two new Team Members attended the Standards Training in Appleton on September 11.
7. Carol Carlson attended the National Association for Drug Court Professionals (NADCP) meeting in July. It was held in National Harbor, MD.

9. All Dodge County arrestees booked into the jail are screened daily for treatment needs. 206 were screened July – September. 166 indicated a need for treatment and were given information on treatment resources. Two were enrolled in treatment under the TAP grant.
