## Dodge County Board of Supervisors February 25, 2020 – 7:00 p.m. Administration Building - Juneau, Wisconsin

The February Session of the Dodge County Board of Supervisors was called to order by Chairman Russell Kottke at 7:00 p.m.

The Board rose to say the Pledge of Allegiance.

Roll call was taken by the Clerk with all Supervisors being in attendance with the exception of Supervisor Nickel who had previously asked to be excused.

Chairman Kottke called for approval of the minutes. A motion was made by Supervisor Caine and seconded by Supervisor Benter to approve the minutes of the January 21, 2020, session of the County Board meeting as recorded, and dispense with the reading of the minutes. The motion passed by acclamation with no negative votes cast, and was so ordered by the Chairman.

#### Communications on File

Karen J. Gibson, County Clerk, read a thank you note from the Hustisford Historical Society and also informed the Board that five letters were received in opposition of the establishment of the Beaver Dam Lake District and three letters were received in favor of the establishment of the Beaver Dam Lake District. Question by Supervisor J. Schmitt answered by Chairman Kottke. The Chairman ordered these be placed on file.

### **Special Orders of Business**

Chairman Kottke called the First Order of Business: Confirm Appointment made by County Board Chair. Replace Supervisor Berres with Supervisor Benter as Dodge County's Official Representative on the PACE Commission. A motion to accept the appointment was made by Supervisor D. Schmidt and seconded by Supervisor Berres. The motion passed by acclamation with no negative votes cast, thereby approving the appointment.

The following Resolutions were read by the Clerk and acted upon by the Board:

Resolution No. 19-63 Resolution Ordering the Establishment of the Beaver Dam Lake District – Land Resources and Parks Committee. A motion for adoption was made by Supervisor Schaefer and seconded by Supervisor Muche. Comments by Supervisors J. Schmitt, Maly, Miller, Guckenberger, Burnett, Derr and Bobholz. Supervisor J. Schmitt made a motion to amend Resolution 19-63 as follows: Pursuant to Wisconsin Statutes 33.26(6), The Dodge County Board of Supervisors specifically excludes all privately owned parcels depicted on the boundary map provided (Exhibit A) which are not represented by the confirmed signature(s) of at least (1) one unique owner of lands on the petition submitted to the Dodge County Board of Supervisors on September 10, 2019. This measure removes 560 parcels of 1104 total proposed district parcels. (+/- 50.7%). Questions by Supervisors Houchin and Bobholz answered by Corporation Counsel Kimberly Nass. Comments by Supervisors Guckenberger, Derr, J. Schmitt and Glewen. Motion by Supervisor Glewen to postpone Resolution 19-63 until the March 17, 2020 County Board meeting. Comments by Supervisors Derr and J. Schmitt. The motion to postpone was seconded by Supervisor Muche. Chairman Kottke called upon Corporation Counsel Kimberly Nass to advise the Board on proper procedures. Ms. Nass stated that a motion to postpone to a time certain is in order, takes precedence over the motion to amend, can be discussed/debated and requires a majority vote to pass. Ms. Nass also advised that the Board needs to act on this Resolution within six months of the date of the public hearing, which was October 3, 2019, so this Resolution needs to be acted on prior to April 3, 2020. The vote was cast on Supervisor Glewen's motion to postpone with 25 ayes and 6 noes. Supervisor Derr informed Chairman Kottke that she had meant to vote no. With changing Supervisor Derr's vote to a no, the vote was cast with 24 ayes and 7 noes, thereby adopting the motion to postpone until the March 17, 2020 County Board meeting.

The vote was cast with 27 ayes and 4 noes, thereby adopting the Resolution.

## Resolution Authorizing the Purchase and Financing of the 2020 Computer and Infrastructure Refresh Project

TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

WHEREAS, the Dodge County Information Technology Committee ("Committee") has considered the current County Department computers and information technology server/network infrastructure and the maintenance and upgrades needed to prevent data loss, enhance user productivity and provide data and system securities; and,

WHEREAS, as proposed by the Information Technology Department ("IT Department"), the Committee has considered the following department and infrastructure upgrades: life-cycle refresh of department computers within the Dodge County Administration Building, Sheriff's Office, and also infrastructure refresh of servers and core networking hardware ("2020 Computer and Infrastructure Refresh Project"); and,

WHEREAS, the IT Department recommends a 4-year replacement cycle for County Department computers, and in the Fall of 2019, the IT Department inventoried County Department computers and determined that one hundred three (103) computers and related equipment require replacement, listed on a document entitled List of Department Computer Equipment, attached hereto as Exhibit "A", at a total cost, excluding interest, not to exceed \$152,339.24 with the cost spread over four (4) years of \$39,739.28 per year; and,

WHEREAS, in the Fall of 2019, the IT Department evaluated Dodge County's server and corenetworking infrastructure and determined that various system hardware require replacement, listed on a document entitled List of Servers and Network Hardware, attached hereto as Exhibit "B", at a total cost, excluding interest, not to exceed \$491,808.60 with the cost spread over four (4) years of approximately \$128,293.40 per year; and,

WHEREAS, the 2020 Computer and Network Infrastructure Refresh Project includes all hardware listed on the attached exhibits, warranty on all equipment, installation, and financing costs; and,

WHEREAS, the 2020 IT Department Budget has \$185,000 to fund the 2020 Computer and Infrastructure Refresh Project; and,

WHEREAS, the IT Department has explored funding sources and financing options for the 2020 Computer and Infrastructure Refresh Project, requested pricing from four different technology leasing and financing lenders as follows:

1 RESOLUTION NO. 19-65 2 3 Authorizing a General Fund Transfer and the Purchase and 4 Installation of Transfer Switches for the Dodge County Detention Facility 5 6 TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN. 7 8 WHEREAS, the Dodge County Building Committee ("Committee") has been informed that 9 two transfer switches at the Dodge County Detention Facility are failing and have become 10 unreliable in operation; and, 11 12 WHEREAS, the Committee has discussed the need to expedite replacement of the transfer 13 switches; and, 14 15 WHEREAS, the Dodge County Physical Facilities Department ("Department") has requested proposals and quotations based on transfer switch size and availability and the availability 16 17 of labor for the installation; and, 18 19 WHEREAS, a quote, in the amount of \$35,600, for the purchase of two Kohler transfer switch systems (Model Nos. KBS-DMTA-0800S and KBS-DMTA-0400S) has been received from 20 21 Total Energy Systems, LLC, of DePere, Wisconsin, and a proposal in an amount not to exceed 22 \$48,950 for the removal of existing transfer switches, installation of the new switches, and minor 23 construction has been received from KW Electric, Inc., of Plymouth, Wisconsin; and. 24 25 WHEREAS, at its meeting on February 6, 2020, the Committee reviewed the proposals and 26 recommended proceeding with the purchase and installation of the transfer switches; and, 27 28 WHEREAS, due to the unexpected deterioration and unreliability of the existing transfer 29 switches, the Department did not budget funds in its 2020 Physical Facilities Budget to cover the 30 cost of this purchase and installation; and, 31 32 WHEREAS, the Committee proposes to fund the purchase and installation of the transfer 33 switches as follows: 34 35 1. \$50,000 from the Jail Assessment Fund; and, 36 37 2. Balance, not to exceed \$34,550, as a General Fund Transfer; and, 38 39 WHEREAS, at its meeting on February 17, 2020, the Dodge County Finance Committee also reviewed the proposals, and has determined that there are sufficient Dodge County funds in the 40 Jail Assessment Fund and the Unassigned General Fund available to fund the purchase and 41 installation of the transfer switches, in an amount not to exceed \$84,550; and. 42 43 WHEREAS, the Finance Committee recommends to the Dodge County Board of 44 Supervisors that the Dodge County Board of Supervisors authorize the use of \$50,000 from the Jail 45 Assessment Fund, and the remaining amount from the Unassigned General Fund, in an amount not to exceed \$34,550; 46

FISCAL NOTE: The Jail Assessment Fund has an anticipated fund balance at 12-31-2019 of \$155,502 and thus has available equity to cover the \$50,000 expenditure portion. The Jail Assessment Fund currently does not currently have a related fund balance policy. The Unassigned General Fund balance is sufficient to allow for this transfer.
