1 RESOLUTION NO. 20-07 2 3 Authorizing Note for Reeseville Highway Shop Construction Project 4 5 TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN, 6 7 WHEREAS, the Dodge County Board of Supervisors approved the construction of a county highway satellite shop in Reeseville on January 20, 2020, by the adoption of Resolution 19-62; and, 8 9 WHEREAS, Resolution 19-62 identified the source of funds for the construction as existing cash 10 11 reserves (internal borrowing) available in the General Fund; and. 12 13 WHEREAS, due to financial uncertainties caused by the COVID-19 pandemic, the Finance Committee determined that it is prudent to maintain cash reserves; and, 14 15 WHEREAS, the Finance Committee, at its meeting on May 11, 2020, authorized the release of a 16 Request for Proposals (RFP) for purposes of soliciting proposals from financial institutions for borrowing 17 \$3,400,000 to fund the Reeseville Highway Shop Construction Project; and, 18 19 WHEREAS, the RFP was released on May 15, 2020, requesting proposals to be submitted no 20 later than June 15, 2020; and, 21 22 WHEREAS, Dodge County's financial advisor and outside bond counsel have advised that the 23 24 amount financed can include cash payments for construction costs made up to sixty (60) days prior to adoption of this resolution; and; 25 26 27 WHEREAS, the Finance Committee received the proposals listed on Exhibit "A", attached hereto, 28 and incorporated herein; and, 29 WHEREAS, the Finance Committee recommends that the Dodge County Board of Supervisors 30 accept the proposal from the financial institution referenced on Exhibit "B", attached hereto, and 31 incorporated herein by reference; 32 33 SO, NOW, THEREFORE, BE IT RESOLVED, by the Dodge County Board of Supervisors 34 that, on the recommendation of the Finance Committee, the proposal from the financial institution 35 referenced on Exhibit "B", attached hereto, and incorporated herein, and the financial terms and 36 conditions set forth on Exhibit "C", attached hereto, and incorporated herein by reference, are hereby 37 adopted; and, 38 39 BE IT FURTHER RESOLVED, that the Finance Director is authorized to execute a Promissory 40
