- 4. APPROVAL OF THE MINUTES OF THE AUGUST 26, 2019, NOVEMBER 25, 2019, AND FEBRUARY 24, 2020 MEETINGS:

Motion by Waukesha County; seconded by Green County, to approve the August 26, 2019, November 25, 2019, and February 24, 2020 Minutes. Motion carried.

5. **CENSUS UPDATE** (as of 6/22/20):

Clearview: 85 of 120 ICF-IID (formerly FDD): 40 of 46

6. **ASSESSMENT RATE SETTING FOR 2021**: A PowerPoint presentation was given to the Committee.

Clearview Assistant Administrator, Lori Kurutz, reported on the current census, as well as the monthly breakdown from January 2019 through the end of May 2020. Kurutz also broke down the census by County for the Nursing Home and the Individuals with Intellectual Disabilities ("IID") households.

Clearview Finance Director, Nicole Grossman, gave a financial update on the following:

- Comparison of payers for the Nursing Home and IID from January 1, 2019 through May 31, 2019 and January 1, 2020 through May 31, 2020.
 - o SNF down 1,565 total days. Down 552 Medicare A days, 58 Medicare Advantage days and 1,500 private days.
 - o IID down 393 Medicaid days and up 18 MCO days.

- 2019 loss calculation for the 2021 rates, using information from the 2019 Cost Report.
 - o MCHA loss is \$77,000 in 2019 vs. \$524,000 in 2018 according to the Medicaid Cost Report.
 - o Based 2021 assessment on \$150,000 loss
- 2019 allocation of overhead.
 - o Total expenses increased in 2019 by \$1,700,000. MCHA portion of overhead increased by \$1,200,000. Behavioral Health units increased by \$188,000.
- 2019 MCHA occupancy
 - o IID occupancy decreased in 2019 over 2018. 2019 89.17%. 2018 95.93%. SNF occupancy decreased in 2019 from 2018. 2019 86.87%. 2018 89.12%
 - o 2020 census through 5/31/2020 reflected 79% Medicaid, 7% MCO, Medicare replacement 5% and private/commercial 8%.
- 2019 MCHA occupancy by County
 - o 5-year utilization is down \$6,683
 - o Provided break down by County on utilization
- Current financial update, as of April 30, 2020 (all budget numbers are pro-rated through April 30, 2020).
 - o MCHA census is down, as a result, revenue is off target due to COVID, facility had to position appropriately.
 - o COVID funding through 4/30/2020 = \$565,881.
 - O Direct expenses less than budget, specifically for transportation and Finance Department.
 - Total expenses at this time are less than budget, however, expected to show more of a loss moving forward.
- The fund balance as of December 31, 2019 was \$12,779.27 with average yearly expenses of \$7,000.00. This sets the rate based on a loss of \$150,000.00. The 2021 assessment payments will be placed in a segregated account and applied as a dollar-for-dollar offset to next year's rate.

Motion by Grant County to approve the assessment rate for 2021 in the amount of \$150,000.00; seconded by Waukesha County. Motion carried.

Motion by Washington County to approve the financial reports as presented; seconded by Green County. Motion carried.
