<u>COVID -19</u>: The Dodge County response to COVID-19 is approaching its seventh month. Dodge County departments remain open and staffed on a daily basis. Committee meetings continue to be held in the Administration Building Auditorium.

With the Court system in full operation, jury selection is conducted in the Administration Building Auditorium. Coordination and advance planning has led to an efficient process. This is a credit to staff from Court Security; Clerk of Courts; District Attorney; Judges; Physical Facilities.

Potential jurors enter the Administration Building through the Oak Street entrance. All are subject to a security check point prior to being directed to the Auditorium. Face coverings are required. The Oak Street entrance provides separation and distancing from other areas of the building and to the public who may be conducting business.

Dodge County Public Health is expanding their contact tracing capacity. The Human Resource & Labor Negotiation Committee supported the request from Public Health Officer Abby Sauer to hire up to four Limited Term Employees as contact tracers. The positions are authorized through December 2020. The emphasis is to seek individuals with an LPN or RN background. Interviews are currently scheduled for the week of September 14th.

<u>Preliminary 2021 Budget</u>: The Preliminary Budget document is scheduled for distribution at the September 22nd County Board meeting. The Finance Committee held two special meetings to review a budget summary in addition to a third review at their September 14th meeting.

As previously noted, the September 28th Special County Board meeting will include individual department presentations. The goal is to have an interactive discussion with Supervisors and department heads. Feedback and further direction by the Board will be incorporated into an updated 2021 budget document which will be provided to all Supervisors at the October 20th County Board meeting. The October 20th Budget document will be the basis for the November 10th Public Hearing.

Route to Recovery: A second Route to Recovery application was submitted to the Wisconsin Department of Administration on Friday September 11. The application totaled \$148,142.09. To date Dodge County has submitted requests totaling \$156,323.43. A further summary of the Route to Recovery Program will be distributed at the September 22nd County Board meeting.

Reeseville Highway Shop: Dodge County is expected to take full ownership of the new facility as of Monday September 21st. The project will be completed on-time and is expected to be under budget.

A public open house of the Reeseville facility is scheduled for Saturday October 10th from 10:00 a.m. – Noon.

Re: Resolution 20-22 Increase to Clearview Soffit & Siding Replacement Project Buget

Siding Replacement Project: The replacement project was authorized by the County Board through Resolution 19-37 with an authorized budget of \$344,050. The budget included an 8% contingency that equated to \$25,000. The project bid was awarded to Home Path Financial LP.

Home Path Financial LP began work on the project as of April 6, 2020. Home Path soon discovered that the project details provided by Dodge County did not match "as built conditions," specifically, the referenced vented cavity directly behind the siding, and the Z furring do not exist. Home Path communicated to Dodge County that in order to obtain product warranty of the HardiePlank siding, attaching the lap siding through the use of Z furrings would be required. The additional work would require a change order of an undetermined amount.

September 10th: Home Path Financial has completed work on the project. Their work has met all standards and conditions, Dodge County is satisfied with the results of their work and the installation of the new lap siding.

Siding replacement project, updates were provided to the Health Facilities Committee on May 6th; June 3rd; July 1st; August 5th and September 2nd. Information related to the project and the request for additional funds was presented to the Finance Committee on August 10th. The Finance Committee reviewed the Resolution Fiscal Note at their September 14th meeting.

Final payment of the second and final change order for \$31,000 is pending. The resolution proposes an increase in the overall project budget to address the change order.
