 USH 151/DE Significant patrol and enforcement has occurred by Dodge Sheriff's Department since last meeting. WISDOT advises of a proposed study in





which a J-Turn is recommended. Permission was given to enter phase 2 of the study and additional proposals could be taken into consideration. No timeline on completion.

County Hwy A/W - Dodge Hwy Department replaced signs and constructed new rumble strips that meet current DOT code. Kempke will look at a sign on County A that may hinder views.

a. BOTS – Bureau of Transportation Safety

Frost presents updates in Community Maps and updates fatal crashes. 8 fatalities in Dodge County in 2020 compared to 13 in 2019. 14% less crashes in 2020 compared to 2019 in Dodge County. 28% more Class A injury crashes in 2020





compared to 2019 in Dodge County. Alcohol related crashes up from 77 in 2019 to 119 in 2020 IN Dodge County. 2 fatal crashes in 2021 so far in Dodge. Preliminary numbers show 599 fatalities in Wisconsin crashes in 2020. Motorcycle fatalities up almost 40% in the state in 2020. Frost will email the power point info. Governors conference scheduled Aug 16-20. BOTS has crash analysis services available for law enforcement.
