Capital Improvement Committee – Preliminary Discussion, 2022-2026 Five Year Capital Improvement Plan – Projects/Equipment

The Plan is necessary for known issues with emergency situations still coming up.

Justice Facility parking lot construction

Phase 2 will close off the back parking lot for employees. The construction should begin late June with each phase lasting approximately 2 weeks.
