## Dodge County Board of Supervisors August 17, 2021 – 7:00 p.m. Administration Building - Juneau, Wisconsin

The August 17, 2021 Meeting of the Dodge County Board of Supervisors was called to order by Chairman Russell Kottke at 7:00 p.m.

The Board rose to say the Pledge of Allegiance.

Roll call was taken by the Clerk with all Supervisors being in attendance with exception of Supervisors Maly and Nickel who had previously asked to be excused. Supervisor Hedrick appeared via teleconference for discussion purposes only.

Chairman Kottke introduced newly elected Supervisor Daniel Siegmann, who is representing County Board Supervisory District No. 10.

Chairman Kottke called for approval of the minutes. A motion was made by Supervisor Caine and seconded by Supervisor Benter to approve the minutes of the July 20, 2021 and July 21, 2021, meetings of the County Board meeting, as recorded. The motion carried by voice vote.

## **Communications on File**

Karen J. Gibson, County Clerk, reported there were no communications on file.

## **Election**

Chairman Kottke appointed Kimberly Nass, Corporation Counsel, Ms. Gibson, and Danielle Van Egtern, Chief Deputy County Clerk as the Ballot Clerks.

Chairman Kottke then opened nominations for One Member – At-Large to the Executive Committee. Supervisor Houchin nominated Supervisor Guckenberger. Supervisor Hilbert nominated Supervisor D. Schmidt. Supervisor Caine nominated Supervisor Benter. Chairman Kottke called for any additional nominations, and hearing none, the ballots were distributed. Comments and questions by Supervisors J. Schmitt and Berres answered by Kimberly Nass, Corporation Counsel. Comments by Supervisors Guckenberger, D. Schmidt, and Benter. After the ballots were cast, the ballot clerks retired to tally the votes. The votes were cast as follows: Supervisor Guckenberger – 16, Supervisor D. Schmidt – 8, Supervisor Benter – 6, thereby electing Supervisor Guckenberger to the Executive Committee.
