


DODGE COUNTY CRIMINAL JUSTICE COLLABORATING COUNCIL

August 10, 2021

Minutes

1. **Call to order:** District Attorney Kurt Klomberg called the meeting to order at 3:02 p.m.
2. **Roll call: Members present were:** Human Service Director Becky Bell; County Administrator James Mielke; Jacob Van Kerkvoorde, Judge Kristine Snow; Mary Wendel.
Others: Managing Attorney, Bob Barrington, Amber Dieter, Judge Joseph Sciascia.
Absent / Excused: Thomas Nickel, Jeana Meyer, Sheriff Dale Schmidt, Donna Braun.
3. **Public Comment:** None.
4. **Approval of Minutes of May 18, 2021:** Motion by James Mielke, 2nd by Mary Wendl to approve the May 18, 2021 minutes as presented. Motion carried.
5. **Report of DTC / IDC Program Director:** Presented by Becky Bell. Discussion regarding DTC/IDC update, discussion regarding TAP/TAD grant revenue and expenses, update on staffing, TAD and BJA grant and upcoming National Drug Court Conference.
6. **Discussion of use of mental Commitments for people with addictions:** DA Klomberg provided council with Memos from Judge Joseph Sciascia and Corporation Counsel Kim Nass. Break from 3:15 pm to 3:25 pm for council review the memos. DA Klomberg asks Judge Sciascia who would start the process for a Chapter 51 in light of his memo. District Attorney Klomberg points out that Chapter 978 defines the authority of the District Attorney and does not authorize the District Attorney to institute Chapter 51 proceedings, consequently the District Attorney may not legally commence a Chapter 51. Discussion regarding terms of deferred agreement with counseling and treatment conditions already in place. Discussion regarding allowing for voluntary treatment versus involuntary commitment for treatment. Discussion regarding transparency of treatment provider's reports. Becky Bell informs the council that she has spoken with the law enforcement committee regarding referrals to Human Services. Mary Wendl speaks to ability to sanction while on probation for not complying with treatment. Jacob Van Kerkvoorde speaks to having treatment conversations with clients and that due to the State Public Defender's Office defending their clients against Chapter 51, they would be unable to petition for one. Discussion regarding Corporation Counsel's Office being the office that would represent the County for any Chapter 51 filed and recommendation that this council does not have the authority to make determinations regarding Corporation Counsel's duties. Becky Bell expressed that the institution and furtherance of mental health commitments is never dictated by costs, mental health services will be delivered to people when appropriate and costs are not a reason that the Department denies mental health treatment.
7. **Determine Next Meeting Date:** Next meeting is scheduled for November 16, 2021 at 3 p.m.

Program Changes/Notes:

1. The Treatment Court Team has been short two case managers for two months. A Treatment Court Case manager has since been hired and will start on 8/23/2021. To meet program needs the remaining case manager position has been redefined as a UA Technician/Jail screener. This position will provide coverage for daily jail screenings of every person booked into the jail so that we are able to provide resources and referrals regardless of the charge. This position has also been filled and will begin 8/24/2021.
2. Treatment Court Team updates: Judge Snow began DTC August 1st. Captain Chad Enright has joined the team. A Treatment Court Team Meeting has been scheduled for September to discuss processes with the new members and a Treatment Court Standards Training will be scheduled as well.
3. The TAD Grant is up for competitive bid at the end of this year. JusticePoint is working with Human Services to write the grant proposal. The proposal for the first year of the new grant cycle will remain the same. The second year of the grant cycle will be opened up for additional funds and grant enhancements. At that time we will be writing in for a certified peer support to join the Treatment Court Team.
4. BJA update: At this time the BJA budget remains unused for this reporting period. Our current TAD grant funds 15 DTC clients and we are only now in August almost at capacity. We have not hired an additional case manager due to this.
5. Three people have received Vivitrol in the jail since the last CJCC report, which is covered by the DHS MAT grant.
6. As a result of staffing and small program numbers Thinking for a Change will temporarily be provided by the JusticePoint T4C programming unit. This will continue to ensure that the delivery of programming is taught to fidelity and that our participants receive Evidenced Based education without interruption. Upon completion of T4C training with the new Dodge County Case Management staff, services will resume in house.
7. The National Drug Court Conference is August 15-18, 2021 in National Harbor, MD. Alisha Nelson will be attending.
