The February Meeting of the Dodge County Board of Supervisors was called to order by Chairman Russell Kottke at 6:00 p.m.

The Board rose to say the Pledge of Allegiance.

This resolution was first presented at the December 21, 2021 County Board Meeting and was laid over to the current meeting. Chairman Kottke referred the resolution to the American Rescue Plan Act (ARPA) Project Evaluation committee.
