The meeting was called to order by Dennis R. Schmidt at 5:00 p.m.

A motion was made by Kavazanjian, and seconded by Houchin to approve the November 17, 2021 minutes, as presented. Motion carried.

Corporation Counsel Kim Nass and Treasurer Patti Hilker reported on the 2022 In Rem No. 1 list of unredeemed parcels. Patti handed out packets of information, so committee members are able to travel to the properties for examining and decision making on foreclosure of properties at the next committee meeting.

Kim Nass and Dennis Schmidt reported on a parcel of real estate located at 270 E. Kindt Street, City of Juneau, Wisconsin, and owned by Jenifer Linendoll. (PIN 241-1115-2723-008). Wes Mulkey and Wesley Mulkey, Jr., were in attendance to discuss possession and clean-up of this property. Kim Nass stated that she had been in contact with the Wisconsin Department of Natural Resources to discuss options regarding ending enforcement action against the property, and she will stay in contact with them. Options for ownership were discussed. The County would take the property for delinquent taxes, proceed to deed to the City of Juneau, and the Mulkeys would have made an agreement with the City of Juneau to give ownership to them. The County would be available to help with the deeding of the property, should the agreement with the City of Juneau take place. The Taxation Committee is in favor of working with these individuals and the City of Juneau to get this property cleaned up.

Kim Nass and Patti Hilker reported on other unredeemed, unsold In Rem properties in Dodge County, pending In Rem actions or tax delinquent properties.

Kim Nass reported on Property located at 612 S. Hubbard, Horicon, WI (PIN 236-1116-0643-057).

Kim Nass and Patti Hilker reported on Village of Lowell, Great American Investment Properties, LLC (PINS 147-1014-1513-002, 147-1014-1513-003, and 147-1014-1513-004).

Kim Nass and Patti Hilker reported on Village of Randolph, Chicago, Milwaukee and St. Paul Railway Co. (PIN 176-1213-0632-139). This property will be deeded to the Village of Randolph after it is taken by tax foreclosure.
