The meeting was called to order by Vice-Chairman Benter at 3:01 p.m.

Public Comment: None.

A motion was made by Kavazanjian, and seconded by Schmidt to approve the March 9, 2022 minutes, as presented. Motion carried.

Corporation Counsel Kim Nass and Treasurer Patti Hilker reported on the 2022 In Rem No. 1 list of unredeemed parcels.

Corporation Counsel Kim Nass and Treasurer Patti Hilker reported on the redemption of PIN 206-1214-3321-108, by Nicole Bach, 305 Carroll Street, Beaver Dam, WI. Patti allowed this property to be bought back by the property owner prior to the sale for all taxes, interest, penalties and all fees incurred.

Open bid or bids on unsold 2022 In Rem properties, and In Rem properties from prior years, and accept, reject, or defer action on the bid or bids. Patti Hilker stated that bids being opened were received timely.

Consider, discuss, and take action to establish or reestablish appraised values or consider other options for 2022 In Rem properties with PIN 111-1015-2814-032, and authorize the Dodge County Treasurer to advertise the In Rem properties. A motion was made by Schmidt, and seconded by Kavazanjan to reestablish the appraised value at \$500 for PIN 111-1015-2814-032 located at 404 East Street in the Village of Clyman. Motion carried. It was noted that any personal items left on the property will be the responsibility of the new owner.

Kim Nass reported on a parcel of real estate located at 270 E. Kindt Street, City of Juneau, Wisconsin, and owned by Jenifer Linendoll. (PIN 241-1115-2723-008).

Kim Nass and Patti Hilker reported on other unredeemed, unsold In Rem properties in Dodge County, pending In Rem actions or tax delinquent properties.

Kim Nass and Patti Hilker reported on CMC Heartland Partners (PIN 020-1117-3132-016), County Road WS, Woodland, WI. The committee recommended Kim and Patti draft a letter to the Town of Herman Town Board, making them aware of certain known issues on the property and having the town work with the interested party in taking actions to address such known issues.

The next regular meeting of the Taxation Committee was not scheduled at this time, due to uncertainty of incoming committee members and availability for meeting attendance.
