Dodge County Board of Supervisors May 17, 2022 – 6:00 p.m. Administration Building - Juneau, Wisconsin

Chairman David Frohling called the May meeting of the Dodge County Board of Supervisors to order at 6:01 p.m.

The Board rose to say the Pledge of Allegiance.

Roll call was taken by the Clerk with all Supervisors being in attendance with the exception of Supervisor Sheahan-Malloy who had previously asked to be excused. District 26 seat remains vacant.

Chairman Frohling called for approval of the minutes. A motion was made by Supervisor Yaroch and seconded by Supervisor Caine to approve the minutes of the April 19, 2022, meeting of the County Board, as recorded. The motion carried by voice vote.
