The November 1, 2022 Meeting of the Dodge County Board of Supervisors was called to order by Chairman David Frohling at 6:03 p.m.

The Board rose to say the Pledge of Allegiance.

Roll call was taken by the Clerk with all Supervisors being in attendance with exception of Supervisor Derr, who had previously asked to be excused. Supervisors Conway, Houchin, and Sheahan-Malloy appeared virtually.

2023 Dodge County Budget Appropriation Public Hearing

Chairman Frohling called upon Karen Gibson, County Clerk, to confirm the publication of the Affidavit for the Public Hearing Notice. Ms. Gibson read the Affidavit of Publication and stated the notice was published on October 15, 2022 in the Beaver Dam Daily Citizen.

The Chairman declared the Public Hearing open at 6:05 p.m., and asked anyone who wished to speak to come forward.

Anthony Mau – N1463 Second Street Road, Watertown WI, 53098 – Spoke against the proposed 2023 budget debt levy.

Andrew J. Schnitzler – 100 Pine Drive, Reeseville WI, 53579 – Spoke against 2023 Budget expenditures related to road construction in County Supervisor District 18 and throughout Dodge County; and American Rescue Plan Act funds granted to the Village of Reeseville.

Daniel Luethje – 232 Woodland Drive, Beaver Dam WI, 53916 – commented against spending related to raising taxes related to the 2023 proposed budget and commented on budget accountability.

Bob Neuman – W8769 Eagle Road, Beaver Dam WI, 53916 – commented on the importance of the Sherriff Office fleet, one on one squad cars and expressed safety concerns in response times to Dodge County citizens.

Jeremy Johnson – 550 N. Fairfield Avenue, Juneau WI, 53039 – commented against debt levy proposed in the 2023 budget and any possible tax increase.

Ross Purdy – N5852 East Avenue, Iron Ridge WI, 53035 – commented against the amount appropriated in the proposed 2023 budget for an emergency response vehicle, increased sales tax, and various department spending.

Melissa Frievalt – W6213 State Road 33, Juneau WI, 53039 – Spoke against the overall proposed 2023 budget and tax increase.

Jerry Kjornes – 434 Ridge Road, Juneau WI, 53039 – Spoke against eliminating a Veteran's Service Office position.

Tom Jacobson – N234 County Road P, Oconomowoc WI, 53066 – spoke against debt levy and tax increases related to the 2023 proposed budget.

Chairman Frohling declared the Public Hearing closed at 6:58 p.m.

County Board Discussion on 2023 Dodge County Budget

Chairman Frohling opened the floor for County Board Supervisors to participate in open discussion on the proposed 2023 Budget. Supervisors engaged in discussion regarding the proposed budget and discussed anticipated amendments. After the board discussion was complete, Chairman Frohling made a statement regarding written amendments and mentioned the follow deadlines.

- Thursday, November 3, 2022 – All anticipated amendments should be submitted to the Finance department so they can be added to the agenda for the Finance Committee meeting scheduled on November 7, 2022.
- Friday, November 11, 2022 by 12:00 p.m. – Any additional anticipated amendments need to be submitted in writing so they can be included on the agenda for the November 15, 2022 County Board meeting.

Chairman Frohling also reminded County Board Supervisors to bring their 2023 budget book to the November 15, 2022 County Board Meeting.

At 7:46 p.m., Supervisor Boelk made a motion to adjourn until Tuesday, November 15, 2022 at 9:00 a.m. Supervisor Steger seconded the motion. The motion to adjourn carried by voice vote.
