\$50 fee includes one post-installation inspection.

\$300 deposit will be returned to owner upon acceptance of completed work. The following exceptions will apply:

- \$50 will be deducted from the deposit for each re-inspection if installation by contractor/owner is unacceptable. The remainder will be returned to owner.
- If installation is unacceptable and Dodge County has to correct the faulty installation, the deposit will be forfeited by owner and actual costs for correction shall be borne by applicant.
- \$50 will be deducted for one six-month permit extension.
