The meeting was called to order by Chairman Houchin at 4:00 p.m.

A motion was made by Nancy Kavazanjian, and seconded by Ed Benter to approve the March 16, 2023, minutes, as presented. Motion carried.

Public Comment: None.

Corporation Counsel Kim Nass and Treasurer Kris Keith reported on the 2023 In Rem No. 1 list of unredeemed parcels.

Corporation Counsel Kim Nass and Treasurer Kris Keith reported on redemption of PIN 024-1016-1942-000, owned by Laverna H. Paul, W4975 Birch Road, Juneau, Wisconsin. –Property was redeemed, Ralph Paul came in a paid all that was due.

Corporation Counsel Kim Nass and Treasurer Kris Keith reported on the status of PIN 038-1017-0542-000, owned by David Buerger, N4650 Lilac Road, Iron Ridge, Wisconsin. David Buerger (deceased) – real estate is listed on Jones Auction site with online bidding 3/24/2023-4/19/2023. The real estate auction packet states no showings until 4/8/2023 and that farm equipment and personal property will be at online auction soon. Corporation Counsel Kim Nass reported that a claim has been filed in the Estate of David Buerger, Case No. 23PR67 for the outstanding property taxes. Taxes will be paid through the estate.

Corporation Counsel Kim Nass and Treasurer Kris Keith reported on the status of PIN 042-1217-2534-002, owned by Scott and Ann Larsen, Zion Church Road, Theresa, Wisconsin. Corporation Counsel Kim Nass reported that the Town of Theresa Clerk has been contacted and indicated the Town's willingness to accept this parcel upon foreclosure by the County. It is an existing cemetery. Per §157.115, Wis. Stats., abandoned cemeteries become the responsibility of the town. Motion made by Randy Vande Zande, seconded by Jayme Klockow, to take parcel and deed to Town of Theresa at no cost to the Town of Theresa. Motion carried.

Corporation Counsel Kim Nass and Treasurer Kris Keith reported on Efrain Osorio Salazar and Janet Osorio, Washington Street, Horicon, WI (PIN 236-1116-0721-000). Corporation Counsel Kim Nass reported that she has been in contact with the City of Horicon Clerk. The City of Horicon is interested in entering into an agreement with the County for this parcel, which agreement would include repaying the County the amount of taxes and specials it has paid out to the City at settlements over the years. City Council will be considering this matter at an upcoming council meeting. If the City Council formally approves entering into an agreement, a resolution and proposed agreement will be brought back to the Taxation Committee for consideration at its next meeting.
