Discuss and Take Action to Repair the Controller on the Transfer Switch for the Generator Located at the Henry Dodge Office Building the estimated cost of the controller is \$7800. A motion was made by Dave Beal and seconded by Steve Kauffeld to repair the controller. Motion carried.

- DDC Upgrades 1st, 2nd, and 4th floor are complete. 3rd floor needs to be finished.
- Bidding for New Chiller at the Dodge County Courthouse bids are out. There will be a walk thru on 4/18/23. Chiller should be installed by the end of the first week in May.
- VMA's at the Dodge County Courthouse/Jail VMA's are complete, but we are still working thru
 some issues.
- Dodge County Jail Federal Inspection the inspection started on Tuesday, and was completed today. The inspector stated that the building is well maintained and very clean. No deficiencies were reported.
- New Chiller at the Dodge County Jail this was discussed earlier.
- Elevators at the Henry Dodge Office Building are finished.
