Petition of the Dodge County Land Resources and Parks Committee to amend the Sanitary Ordinance, Dodge County, Wisconsin. The petition includes a series of amendments that are intended to clarify the maintenance, reporting and maintenance fee requirements for private onsite wastewater treatment systems and its components, for holding tanks and for alternative sanitation systems. The petition also includes definitions of certain terms used within the Ordinance. A copy of the proposed amendment is enclosed and is available for review in the County Land Resources and Parks Department between the hours of 8:00 a.m. and 4:30 p.m., Monday-Friday (920-386-3700).
