## **PUBLIC HEARING**

Russell Weiss - Request for a variance to the terms of the Highway Setback Overlay District provisions of the Dodge County Land Use Code to allow the construction of a 9' by 27' porch addition to the northeast side of the residence on this lot where said addition will be located 42 feet from the centerline of Lake Drive, or 18 feet within the required highway setback and where said addition is considered by the County as an expansion of a non-conforming structure. The site is known as Lots 60 and 61, Sinissippi Flats. The site is located in part of the NE ¼, SE ¼, Section 4, Town of Hustisford, the site address being N4699 Lake Drive.

Motion by Leon Schraufnagel to grant the variance to the terms of the Highway Setback Overlay District provisions of the Dodge County Land Use Code to allow the construction of a 9' by 27' porch addition to the northeast side of the residence on this lot where said addition will be located 42 feet from the centerline of Lake Drive, or 18 feet within the required highway setback and where said addition is considered by the County as an expansion of a non-conforming structure subject to the following conditions:

- This porch addition shall perpetually remain an open porch and shall not be screened in or enclosed in any manner in order to create a screen porch or other room addition;
- 2. The proposed addition shall limited to a roof overhang addition only and the addition shall not exceed the dimensions of 9'X27'
