PLUM CREEK DAIRY LLC - for a variance to the terms of the Lot Line Setback Provisions of the Dodge County Land Use Code to allow construction of Manure Storage (Sand Separator). Where said structure will not comply with the terms of the Dodge County Land Use Code. Per Subsection 6.2.11 of the Land Use Code the county adopts Wisconsin Administrative Code ATCP 51 (51.12) which states minimum setbacks for manure storage structures (Sand Separation System) to the lot line shall be greater than 350 feet. As proposed, the aforementioned project is to be located approximately 228 feet from the side property line to the west, thus not in compliance with the Code.

The site is located: SW ¼, SE ¼, Section 20, T13N, R14E, Town of Trenton, Dodge County, Wisconsin the site address being W8998 Laurel Hill Road.

A Dodge County Land Use Permit shall be filed with the Dapartment.

2. PUBLIC HEARING - 7:15 P.M.

CURTIS & AMANDA CHRISTIAN - for a variance to the terms of the Fencing Requirements – Swimming Pools, Spas and Hot tubs Provisions of the Dodge County Land Use Code to allow the use of alternative safety measures (Fiberglass encapsulated retractable safety cover). Where said cover is not recognized as a safety devise/fence according to the terms of the 6.4.2. of the Dodge County Land Use Code, thus not in compliance with the Code.

The site is located: Lot 1 CSM 6727 in v45 p307 being pt NE1/4 NW1/4 Section 34, Town of Lomira, Dodge County, Wisconsin the site address being W1179 County Road AH

1. A Dodge County Land Use Permit shall be filed with the Dapartment.
