Reconvened into Open Session at 8:05 p.m.

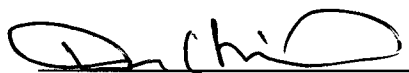
Motion was made by Herren to reconvene in open session. Second by Wanie. Motion carried.

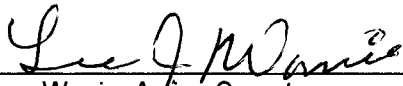
OTHERS PRESENT: Sgt. Todd Wagner, Columbia County Sheriff's Department

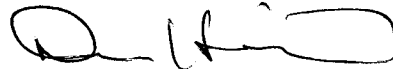
Closed Session:
