September 17, 2024 – 6:00 p.m.
Administration Building - Juneau, Wisconsin**

The September Meeting of the Dodge County Board of Supervisors was called to order by Chairman David Frohling at 6:00 p.m.

The Board rose to say the Pledge of Allegiance.
