Dale and Wendy Klueger for a variance request was submitted by the appellant with a request to construct a detached garage south of the existing residence. As proposed, the project will be located 78.42 feet from the centerline of County Road Y or 21.58 feet within the required setback, 45.42 feet from the Road Right of Way of County Road Y or 21.58 feet within the required setback, and 7.5 feet from the existing residence or 2.5 feet within the required setback and thus prohibited by the code. Part of the NW ¼ of the NW ¼, Section 26, Town of Leroy, the site address being N10404 County Road Y. As proposed, the project will be located 44.5 feet from the centerline of Hickory Bay Drive or 15.5 feet within the required setback and 11.5 feet from the Road Right of Way of Hickory Bay Drive or 15.5 feet within the required setback and thus prohibited by the code.
