**2025 Dodge County Budget Appropriation Public Hearing**

Chairman Frohling called upon Danielle J. Van Egtern, County Clerk, to confirm the publication of the Affidavit for the Public Hearing Notice. Ms. Van Egtern read the Affidavit of Publication and stated the notice was published on October 15, 2024, in the Beaver Dam Daily Citizen.
